# SEPTIC SYSTEM INFORMATION

## **Permits**

Septic permits are required when installing, repairing, or making changes (additions, etc) to a septic system. To obtain a septic permit, a site evaluation and design must be conducted by a licensed septic contractor and submitted to the Becker County Planning & Zoning office.

#### **Permit Fees**

\$225 for a residential system \$300 for a commercial system

A fine of three times the original fee will be imposed on any permit after the start of the project for which the permit is required, and the evaluation of the project is less than \$5,000.

A fine of \$500 and five times the original fee will be imposed on any permit after the start of the project for which a permit is required, and the evaluation is more than \$5,000.

#### **Installation**

**In-ground systems** may be installed by the homeowner.

Mounds, at grades, pressure beds, or systems with lift stations must be installed by a licensed contractor.

## **Inspections & Certificates of Compliance**

Once the system has been installed, the system will be inspected by our office. If the system has been installed correctly, a certificate of compliance will be issued.

Certificates of Compliance on existing systems may be obtained by contacting a Designer and having a compliance inspection conducted.

#### **Classification of Septic Contractors**

*Inspector* - Conducts septic compliance inspections.

**Designer** - Conducts site evaluations to properly locate septic systems on the property.

*Installer* - Constructs, installs, alters, and repairs septic systems.

**Pumper -** Removes septage from tanks and properly disposes of the septage.
