

Board of Supervisors Regular Meeting Wednesday, August 15, 2018

Meeting Minutes

The regular meeting of the Becker Soil and Water Conservation District Board of Supervisors was held on Wednesday, August 15, 2018 in the Conference Room of the USDA Ag Center Building located at 809 8th Street SE, Detroit Lakes, MN.

He has been a valued asset to the Shoreline Program. TNC Agreement for Services

Peter provided Todd Holman (nature conservancy) a draft agreement for services. This would provide
the SWCD 18,000 a year for 3 years to provide outreach and biologist services in portions of Becker,
Clearwater, Hubbard, and Crow Wing counties. No official agreement in place but seeking approval to
enter agreement.
