The following survey data was obtained from the recent Dunton Locks County Park Workshop and the online survey that was posted on the County's webpage. Twenty-five people responded to the County Survey (workshop/online). The County sought public feedback in the following areas: **Activities at the Park, Facilities, Maintenance/Management, Enforcement,** and **Signage/Wayfinding**. Survey summary efforts below aim to prioritize survey feedback and list comments as they appeared for each of the aforementioned areas.

COMMENTS RELATED TO SPECIFIC ACTIVITIES:

1. Hiking

• Nice rugged trails, but a concern about soil erosion and lack of adequate trail maintenance expressed (6 comments).

2. Bird/Wildlife Watching

- Great area for birding; its designated as a Pine to Prairie Birding Trail (2 comments).
- More observation areas for birds are desired a couple of additional piers for wildlife watching would be great (2 comments).

3. Biking

- More paved trails (family) and loop where trail ends. Reference to regular maintenance/repair work needed (6 comments).
- Need better/improve Mt. Bike Trails; create one-way trails to increase safety and enjoyment (2 comments).

4. Events/Private Gatherings

- Great setup with ample parking and nice features.
- Never considered this venue.

5. Picnicking

• Great setup and enjoy picnicking here.

Too much competition in DL.

6. Fishing

- This activity is very important here lack of shore fishing opportunities critical to maintain and enhance at park; expand/enhance fishing. Shore fishing enhanced by protecting water quality (Detroit, Muskrat, Sallie)[2 comments].
- Create a couple groomed spots along No. side of Muskrat Lake.
- Need a new dock on Sallie and Muskrat Lake.

7. Ccx-skiing

- Groomed?
- Don't ski (2 comments).
- Not long enough or unique enough.
- If trails aren't groomed for skiing make them available for snowshoeing and fatbiking.
- Excellent terrain flatter beginners' area should be improved on the eastern trails.

8. Snowshoeing

- Do not snowshoe (2 comments).
- 9. Other: Photography (see first bullet under Other Comments section below).

OTHER COMMENTS

- Having quiet areas to sit in park, for wildlife, scenic watching, nature study area for children and photography (lots of nature/professional photographers use the park); *Watchable Wildlife Area* (binoculars signage) [6 Comments].
- Snowmobile use (heavy) and develop snowmobile trail from West to DL. (2 Comments)
- Park being a great biking destination and Heartland Trail Connection (Dunton Locks Trail) [2 comments].
- Trails are heavily used for dog walking, but people are not cleaning up after their dogs.
- Great place to run.
- Create a kayak launch area.
- Possible Heartland connection.
- Don't get to Dunton Locks much live 11 miles away.
- Primitive camping yurts.
- County fishing dock by VFW shelter should be replaced.
- Make trail uses compatible with DNR land to the north.
- Buckthorn is an issue to the woods north side.
- What trail uses are eligible on private property move trail use on non-county lands.
- County needs to stop mowing let natural vegetation grow.
- Kind of forget it is there and available for use.
- Need garbage cans and signs depicting uses allowed.

5. Parking Lot – Central

- Parking entrance, guidance; entrance clarity; Better entrance directions on West side coming south on 19; West, better internal direction signage; for someone unfamiliar with the park the signage is not all that easy to follow (5 comments).
- Right of Way/road markings need to point to the parking lot road to the left as approaching the
 park and not lead into the DNR parking lot. Exiting the DNR parking lots also needs a stop sign.
 Public exiting the parking lot road should have the right of way.
- A map would be nice for people to see the trailhead.

6. Parking Lot – Off Hwy 59

- East, better internal direction signage; Better internal signage.
- Get rid of temporary saw horses that have been there for years.

8. Hiking Trails

- Trail signage (distance, maps, etc.,); Distances of trails would be nice; Existing trail signs not very helpful (3 comments).
- More pleasing signage on all trails (not blue and safety yellow metal).
- Maybe better signage on the north trails in regard to picking up after your pooch.
- Dog pick up stations.

9. Biking Trails

- These could be made to accommodate fat bikes.
- No bike trail signage that I've seen.

OTHER COMMENTS

- Overall signage needs consistency.
- Central Parking Lot is not signed well.
- Why is there a fence before So. picnic shelter?
- Eagle Scouts entry kiosk signage
- "This is where you are..." signage relative to where you are in the park. Distance = highlighted.
- Should have signs regarding dog walking i.e. leashes and picking up after dogs maybe poo bags could be provided.
- Biking trails should be one-way, with improved signage and limits on walking or other uses. Also facilities should be better able to accommodate fat bikes, kayaks and other emerging uses.
