Clarence Suvanto, Spruce Grove Township. He discussed the need for building codes in Becker County. He also talked about the rumble strips used to warn of stopping at intersections. In speaking with the State he found they were in favor of using rumble strips. He felt Becker County should use these on a priority basis. He spoke about receiving information from the Attorney General's Office concerning Assessing Property. His concern was that Assessing between Counties should be uniform. He was also concerned about the recent ruling that ATV's could travel with open bottles on roads.

- 5. Building Maintenance Capital Purchase Requests:

- 5. It was moved and seconded to approve the Purchase of Services Agreement with Rural Minnesota CEP for Minnesota Family Investment Program and Diversionary Work Program for Calendar Year 2007 (Salminen, Knutson), carried.
- 6. It was moved and seconded to approve the Community Health Claims (Knutson, Nelson), carried.
- 7. It was moved and seconded to approve the Transit Claims (Salminen, Knutson), carried.

## Human Resources/Update on Personnel Policy

1. It was moved and seconded to pass Resolution No. 06-12-1C, modifying the County Personnel Policy Section 3.0, Recruitment for Position Openings and Section 4.0 Selection of Applicants. The Changes update the process to be more reflective of the current practice. These policies will supersede prior County policies on Recruitment for Position Openings and Selection of Applicants (Salminen, Nelson), carried.

# Highway

- 1. It was moved and seconded to pass Resolution No. 12-06-1A, implementing the 2007 Five Year Construction Plan 2007-2011 (Nelson, Knutson), carried.
- 2. It was moved and seconded to pass Resolution No. 12-06-1B, authorizing the Engineer to advertise and re-fill one Maintenance Worker Foreman Vacancy through the normal County process to be in place after March 1, 2007 (Knutson, Salminen), carried.

## Elected Officials Salaries/Reports and Discussion

1. The Committee met on Monday to discuss the Elected Officials Salaries. Brian Berg briefed the County Board on the meeting. It was moved and seconded to pass Resolution 06-12-1E, ratifying the following salaries of the following elected officials for 2007 (Salminen, Nelson), carried.

Tim Gordon, County Sheriff: \$78,788
Darlene Maneval, County Recorder \$56,506
Ryan Tangen, County Auditor Treasurer \$77,592

- 2. The County Board discussed the County Board Salaries for 2007.
  - a) It was moved and seconded to increase the salary \$1,300, which is the negotiated amount for insurance and a 0% increase for cost of living (Nelson, Bristlin), Commissioner's Knutson, Mulari and Bristlin voting nay. Motion failed. Roll Call Vote: Commissioner Knutson Nay; Commissioner Salminen Yea; Commissioner Mulari Nay; Commissioner Bristlin Nay; Commissioner Nelson Yea.
  - b) Commissioner Knutson stated that \$1,031 would be more acceptable, with 0% increase for cost of living. It was moved to accept this motion (Nelson), Motion failed (lack of second).
  - c) It was moved to table this decision until the next Board Meeting (Bristlin), Motion failed (lack of second).
  - d) It was moved and seconded to increase the County Board Salary by \$1,000 with a 3% increase for cost of living (Bristlin, Nelson), motion and second were withdrawn
  - e) It was moved and seconded to increase the County Board Salary by \$1,300, which is the negotiated amount for insurance and a 1% cost of living increase (Salminen, Nelson), carried. Roll Call Vote: Commissioner Knutson Nay; Commissioner Salminen Yea; Commissioner Mulari Yea; Commissioner Bristlin Nay; and Commissioner Nelson Yea.
