Mission: The mission of Becker County EDA is to develop, enhance, and promote economic development through agriculture, tourism, manufacturing, timber and housing.

Goal 1—Make Becker County EDA a primary facilitator for economic development efforts in the County.

- Create a supportive image with all governmental entities in the county
- Maintain rotating meetings
- Provide quality services in identified areas
- Establish an annual joint session with the boards of the Becker County EDA and Detroit Lakes Development Authority
- Work as a collaborator, integrator and facilitator with existing programs

Goal 2—Enhance the tax base of Becker County.

- Create 250 quality jobs in five years
- Develop \$3 million to \$5 million in financial resources over five years

2003 BECKER COUNTY COMPREHENSIVE PLAN (excerpts)

Vision (next 20 years): Becker County has a diverse economy that includes many sustainable businesses in tourism, retail, service, technology, manufacturing, forestry, and agriculture. Economic opportunities for wage earners and entrepreneurs, quality housing, and quality education are available for all people, and provide local opportunities for our children.

Five concerns expressed in writing goals:

- Supporting existing businesses and industry
- Encouraging economic growth and diversity
- Promoting the County's many assets for economic growth
- Minimizing nuisances and conflicts between economic and residential land uses
- The importance of housing as an economic development tool

Economic Development Goal—Becker County will support and encourage existing tourist, forestry, services, and manufacturing businesses.

Economic Growth and Diversity Goal—Becker County will encourage investment in infrastructure and technology to support new industries and diversify its economy, with concern for environmental quality.

Promotion Goal—Becker County will promote the County's educational, leisure, and quality-of-life assets.

Economic Development and Land Use Goal—Becker County will work with federal, state, city and township governments, and with the White Earth Reservation to ensure sufficient land, infrastructure, housing,, and transportation access for staged economic development throughout the county.

Housing Goal—Becker County will facilitate the development of adequate and affordable housing.
