G Fischer reviewed the activities of the Otter Tail Gateway Task Force and the Heartland Trail extension from Detroit Lakes to Frazee; discussion followed. G Fischer presented information on Carbon Neutral Tourism, the Energy Group ideas, Pelican River Watershed to digitize county ditch records, and information on MedPac and RMB's future plans. - 6) Monthly Housing Update Report: J Thomsen reported on the State of MN's new bidding threshold; discussion followed; the EDA recommended that the County Board look at it first; no action taken. Discussion followed on dropping the sales prices of the new construction homes; the general consensus was to give things more time to turn around; no action taken. Motion and second to accept the update report (H Salminen, P Joyce), carried.
