d) 2014 EDA General Fund Budget: Revenues: Staff presented the following for Board consideration: Taxes & Intergovernmental Revenue \$177,376, Interest & Dividend Revenue \$4,000; Administration Expenditures \$175,633, Other Expenditures \$3,727; Upon Partnership Selling Maple Avenue Apartments potential inflow from repayment of loan \$35,000 and return of equity \$2,700; potential outflow from purchase of Maple Avenue Apartments \$1 and payoff of loan \$140,714 and operations/rehab/modernization \$203,701.
