6. EDA: Broadband Discussion with Century Link Representatives

Century Link reps: Judd Syverson (eng.), Dan Sprague, and Kirsten Suisten (TC and Greater MN Rep.). Century Link is incumbent provider. CAF II (Connect America Funds) improvements centered in and around Detroit Lakes. CAF II is a 6 year program \$324 million secured for 73 Co. in State of MN. Aim is to drive fiber deeper into communities. Good news is that per our area improvements will help 15,500 customers achieve upgraded faster speeds. Anticipate spending approx. \$7 million in upgrades in the DL area. 2017 build slated for DL area. 110 miles of fiber placement.

Barry Nelson – consider using the \$250,000 the County will receive from wetland credits for the purpose of helping to provide for those who aren't being served. ID gaps/opportunities where this money could be leveraged as part of working with partners (Arvig and Century Link). Importance of broadband to economic development and attracting business. Also e- learning. Wondered about local hiring? CL did not yet know but anticipated that some local hiring will occur.

<u>Other EDA topic areas briefly updated</u>: Broadband mtg., Gary's furniture bldg., MN Housing Partnership (Housing Instit. Program begins May9th-10 at the Holiday Inn in DL, Audubon wind turbine project, Lake Access Improvements, Safe and Secure Courthouse Initiative Grant Application.
