- 5. Housing:
  - West River Management (Marcia Otte, Brittani Hogenson, Liz Kuoppala): review of West River CSP Self Assessment Tool survey results; discussion of coordinated entry/ranking system must pick highest ranking which indicates highest need and for some of those chosen the local supports aren't in place; question about tenant outcomes some have transitioned successfully so there are some success stories; usually stay is approx. 18 months, question about access to local facilities by those in our area who are also in need, but who might not rank as high (wondering if local community supports/ties contribute to better outcomes).
  - Review financials and approve paying bills: motion to approve by Ludtke, 2<sup>nd</sup> by Askin motion carried.
  - Quote for Willow Property Improvements: motion to approve low quote (Advanced Flooring Sales) by Knutson, 2<sup>nd</sup> by Ludtke – motion carried.
  - From Check Register/Invoices Presented: Workshop \$722.32, Hwy 34 Group Home \$1,141.68, Low Income Public Housing \$18,594.23, Willow Property \$0.00, Maple Ave. Apts. \$3,889.35, Hidden Hills Group Home \$0.00, West River Townhomes \$7,704.55, and Section 8 Voucher \$16,484.00.
  - Letter of Support for Essentia seeking WCI grant for Health Map project: motion to approve Knutson, 2<sup>nd</sup> by Ludtke, motion approved.
  - DL Area Housing Team: Updates on i. Frazee Downtown site redevelopment (Developing RFP's for site and community planning efforts for which Frazee is seeking WCI grant funding; ii) Housing

Trust Fund – MHP working to get \$2million in funding to develop Housing Trust Funds in anticipation of Federal monies being reduced; EDA's /HRA's eligible to request \$100,000 if they levy for \$100,000. Trying to encourage local EDA's/HRA's to invest in affordable housing on an ongoing basis (beyond the match).
