 - Review financials and approve paying bills
 - From Check Register/Invoices Presented: Workshop \$1,030.43, Hwy 34 Group Home \$0.00, Low Income Public Housing \$11,041,87, Willow Property \$535.60, Maple Ave. Apts. \$5,281.40, Hidden Hills Group Home \$0.00, West River Townhomes \$9,265.19, and Section 8 Voucher \$16,081.00.  - WRT Update; staff contacted Carla Solem (regional continuum of care coordinator) she is setting up meeting to include Mahube to discuss current data and efforts to improve outcomes at West River and staff continues to seek more coordinated services on site. Grant programs are coming up soon which could be utilized to address gaps so best to discuss issues and opportunities now.
 - Discussion of Jan Logan's proposed "Jeremiah project" (18 unit development) which seeks to transition women (and their children) who continue to need assistance and supports (beyond what the Crisis Center can provide) with housing/health care/education to successfully transition beyond the cycle of violence/dependency that brings them into the crisis center.
 - Community Land Trust when will the process start to explore development of a CLT? Kelli Winter with West Central MN Community Action is seeking MN Housing Partnership funding to hire a consultant to help gather community support and hold partner meetings. Should know soon 1-2 weeks if the funding will be made available.
 - Broadband Staff attended workshop/charrette in Brainerd; discussion on what other communities were doing; county ranking change from last year; At 25 mbps down and 3 up (goal

by 2022) we are at 88.94% served in the County (in 2017 it was 69.41%); At 100 mbps down and 20 up (goal by 2026) we are at 12.95% (roughly double where we were at last year: 6.58% in 2017). Staff seeking to share survey results with local vendors as a prelude to further discussion.
