- IV. CONSENT ITEMS
  - a. Mary Hendrickson inquired about locations for roof claims under public housing. Beck informed Wisconsin St in Callaway, Ash Ave in Frazee, and Sharon St in Detroit Lakes. Mary Hendrickson inquired about housing vouchers being used. Beck responded.

- VI. HOUSING UPDATES (Beck MMCDC)
  - a. MURL Update still waiting on response from contractor to put basement under house in Frazee.
  - b. Public Housing vacation of unit being rescinded. 55 vouchers in use. 4 prospective renters. Inquiry from County resident about building rental units if MMCDC could fill with tenants. Discussion of location and issues amongst board members.
  - c. Housing Subcommittee (Klyve) First meeting report summary. Presented committee idea for housing development regarding locations, partnerships, contractors, and EDA role. Presented land purchase auction opportunity for development near Detroit Lakes. Vareberg inquired about consensus of rentals. MMCDC inquired who would manage the property rental. Hendrickson commented about permit problems with putting rentals in this location. Discussion about other locations. Piper commented that there is an inventory of county and city owned properties available for development already. Oman commented about process of buying land vs providing incentives to developers and TIF vs Tax Abatement possibilities. Vareberg proposed private parcel and building single family homes with individual utilities. Jepson asked if Board wanted to pursue land auction or purchase of other land. Hendrickson commented on available funds and board. Oman recommended incorporating land acquisition into Comprehensive Economic
